

Members retiring from the Committee of a State Centre or Local Centre after completion of six sessions at a stretch in any capacity, or having been elected for consecutive three tenures but not completing full six sessions due to any reason, shall not be eligible for election without giving a break of minimum two sessions.

Interested Corporate Members are hereby called upon to visit www.ieindia.org/www.ieelections.in and submit their self-nominations online. While filling the online proforma, they would also be required to submit updated biodata (2000 characters) and non-refundable earnest money of ₹ 3000/- (Rupees Three Thousand) online. The last date for online submission of the self-nomination is **21 Sept 2025**

A member attached to a Division shall be eligible to submit self-nomination for election only in that Division. The earnest money is payable online only.

N.B. The nomination submission procedure (including the remittance) is completely online and the candidates are not required to forward any hard copy for this purpose.

C. Submitting self-nominations along with other requisites

- i. A Corporate Member willing to contest in the election shall nominate himself and submit the nomination alongwith biodata and the earnest money deposit through the online portal, dedicated for IEI elections. The link of the portal shall be available in IEI website.
- ii. For submitting self-nomination, candidate must be on the roll and reachable electronically as on 31 Mar of the year and must also be attached to the same Division of Engineering in the previous two consecutive electoral rolls.
- iii. The credentials for login are to be generated by a member himself through the '_Get Password' option in the election portal by using his membership no. (e.g. AM1498757, F-1258972, M-0025688 etc.).
- iv. While submitting nomination, the number of seats for a given election shall be shown by the System automatically and the member has to provide his membership no. and opt for the election he is willing to contest.
- v. Upon successful entry of the details as stated above, the contestant has to make a payment as non-refundable earnest deposit as per following:
 - a. For election to the Council seat — Rs.20,000
 - b. For election to the State Centre Committee — Rs.5,000
 - c. For election to the Local Centre Committee — Rs.3,000

The applicable amount to be paid for an election shall be displayed in the system.

- vi. After successful payment, candidate has to submit his bio-data (maximum 2000 character including spaces). Any extra character provided shall be automatically truncated by the system. The Candidate shall be able to update his biodata till the last date of submission nomination. No further editing of biodata by the candidate is permissible after this last date.
- vii. In case any member willing to contest for more than one election he has to submit separate nomination for every type of election along with requisite earnest money
- viii. For any payment related issue, the user may send email to caffairs@ieindia.org/ ad_ca@ieindia.org.

E. Withdrawal of nominations

- i. Once submitted, a candidate can withdraw his / her nomination by logging in to the election portal during the period provided for the purpose. However, the earnest money paid during submission of nomination shall not be refundable under any circumstances.
- ii. In case the number of nomination(s) received is/are less than or equal to the number of seat(s) in an election, the said election shall not proceed to the next stage i.e. e-voting and BOS can take the printout of such candidates who stand elected uncontested and such information shall be made available in election site as well.
